What is the Christian Legal Society?

The Christian Legal Society (CLS) is a membership organization of Christian legal professionals, law students, and other individuals dedicated to serving Jesus Christ through the practice of law, the defense of religious freedom, and the provision of legal aid to the poor and needy.



Since 1961, CLS members have proclaimed the Word of God and practiced Christian principles through four primary ministries:

Attorney Ministries

CLS attorney chapters throughout the country provide legal professionals with a wide range of opportunities. These include Christian fellowship and spiritual development, discipleship, law student mentoring, contributions to *The Christian Lawyer* magazine, legal referrals, and volunteer legal service on behalf of the poor and needy.

Law Student Ministries

CLS helps students in law schools across the country integrate their Christian faith with the study and eventual practice of law. Our Law Student Ministries include Bible studies, one-on-one mentoring, student-focused conferences, and faith-based curriculum services to law schools.

Legal Aid Ministries

Since 2000, thousands of CLS members have donated hundreds of thousands of legal service hours to helping the disadvantaged untangle legal issues, seek Christian guidance for personal problems, and understand their rights under the law.

Center for Law and Religious Freedom (CLRF)

As the country's oldest Christian advocacy ministry for religious liberty, CLRF has initiated lawsuits, argued cases, filed amicus briefs, and worked with Congress to defend our Constitution's First Amendment protection of religious freedom.

Working collaboratively with thousands of lay people, CLS runs programs in hundreds of cities throughout the United States. We receive no government funds and are entirely supported by membership dues, foundations, partner organizations, and individual donations.





Legal Aid Services for the Needy

CLS members can choose to volunteer their time at one of many locally run legal aid clinics around the country. Volunteers receive free training and other resources to help them guide disadvantaged citizens in overcoming personal and legal obstacles, such as housing problems, racial discrimination, and denial of Social Security benefits.
