JERRY ROOT

Dr. Jerry Root was born and raised in Southern California. Jerry has been studying C. S. Lewis and a constellation of subjects related to Lewis since 1970. Both his M.Div. thesis and Ph.D. dissertation were about C. S. Lewis. He has taught college and university courses on C. S. Lewis continuously since 1980. He has lectured on Lewis at 59 colleges and universities in nine different countries and has preached or lectured in 24 different countries and 32 states.



SAMMY RODRIGUEZ

Rev. Dr. Samuel Rodriguez is the President of the National Hispanic Christian Leadership Conference (NHCLC)/CONEL, the world's largest Hispanic Christian organization, serving as a representative voice for the more than 100 million Hispanic Evangelicals assembled in over 40,118 U.S. churches and over 450,000 churches spread throughout the Spanish-speaking diaspora. Dr. Rodriguez has been found on many lists of influencers in America, which have recognized his impact across the religious and Latino communities.

God shows us there is a higher law than human law, one from which the authority and justice of man's law flows into bountiful life.

Accordingly, Christian legal theories are often presented in terms of knowledge about law so that what we know of the higher law informs what we should affirm or deny about human law.

But another important kind of Christian knowledge about law is how to praise God in relation to it. This praise stirs up and responds to the joy that Christians experience in law, just as praise does when it recognizes and replies to God's presence in other parts of creation.

In keeping with this year's theme, the symposium will consider four Christian classics of legal praise: Justinian's Introduction to the Corpus Iuris Civilis, Eusebius' Encomium, Fortescue's In Praise of the Laws of England and Melanchthon's On the Legal Arts. The aim is to remind us of the joyful aspect of classical Christian jurisprudence, which is concerned not only with "what law should be," but also how Christians can respond to "law as it is" with praise, thanksgiving, and joy.
