Dr. Bruce Wearne, who lives in south-eastern Australia at Point Lonsdale, has been promoting a biblically-directed Christian social theory since his undergraduate studies at Monash University (1969-1971). Along the way he has published an extensive critical interpretation of the theoretical development of Talcott Parsons (1902-1979) and also serves on the editorial board of The American Sociologist. In recent times he has been editing on-line annotated bibliographies of the works of various "reformational" scholars for "All of Life Redeemed", UK. James W Skillen has been one of those scholars and it was while examining Skillen's 1980s and 1990s contributions to the Christian Legal Society Quarterly that he concluded that these should be brought together in one volume to encourage a new generation of Christian students in their pursuit of public justice.
